

COMMON PROTOCOL FOR THE USE OF A CHEMICAL PEELING

1. PREPARATION: clean the skin to eliminate the excess of grease and makeup.

Products recommended:

- NEF179 Soft soap or with AHA
- NEF279 Astringent Tonic
- NEF199 Degreaser
- NEF294 Mechanical Exfoliation
- NEF647 8% Glycolic Acid Gel
- NEF204 20% Glycolic Acid Gel

2. APPLICATION of chemical peeling

Precautions:

- » Protect sensitive areas with vaseline
- » Exclude the area around eyes and lips
- » In case of burning, place cold cloths in the treated area to relieve discomfort
- » Progressive application time, per session: 1-3min ▶ 7min ▶ 10min

3. NEUTRALIZATION if precise (depends on the acid or if the ph is less than 3.5). If not, remove with abundant water.

- NEF61 Neutralizer (Spray)
- NEF663 Neutralizer Versicolor (Gel) ^{New!}

4. BOOST (optional)

- NEF260 Retinol Cream 4%
- NEF296 Retinol Cream 10%

5. POST-TREATMENT. It is recommended to avoid complications or reduce the risk of hyperpigmentation.

It has a purpose:

- » To calm
- » To protect

** The absence of cutaneous disappearance does not mean null or low effectiveness*



AFTERCARE

In order to **maximize and extend the results** of a professional chemical peel, it is recommended to follow the treatment at home. This will be customized according to the patient (characteristics of the skin) and class (depth) of elaborate peeling. General recommendations:

1st and 2nd week: treat the dryness, erythema, itching and / or sensitivity caused.

- » Cosmetic products that calm and moisturize the skin are recommended. Those rich in Panthenol, Urea or Hyaluronic Acid stand out.

» Topical products rich in antioxidants are recommended. Those containing Niacinamide, Ferulic Acid, Vitamin E and / or Vitamin C are predominant.

» Photoprotectors (minimum one SPF 30) are essential.

From the 3rd week: moisturize and protect the skin

** To increase the absorption of peels, the use of retinol 0.25% (NEF298) 1 month before treatment could be recommended. The thickness of the stratum corneum is reduced, achieving a greater uniformity of application of the chemical peel (discontinue 2 weeks before treatment).*

** Optimal treatment: 6 sessions of progressive intensity.*

CHEMICAL PEELINGS

The renovation your skin needs

Chemical peels are **topical treatments**, mainly formulated on acids, designed to **eliminate in a controlled way** the most superficial layers of the skin, stimulating cell renewal and improving significantly its appearance. The most remarkable clinical effect is rejuvenation.

Mostly are applied at **facial level**. Despite this, they are also highly effective for **body treatments**. In this case, the most common would be: **lactic acid, glycolic acid and TCA**.

They can be found in various cosmetic forms: **solutions, gels, creams or masks**.

CHEMICAL PEELING ADVANTAGES

- » Economic
- » Improves the appearance of the skin
- » Multiple uses
- » Safe and effective
- » They can be used on face and body
- » They can be combined with other techniques such as mesotherapy or dermabrasion

CLASSIFICATION BASED ON THE DEPTH OF ACTION

Very shallow

- » Glycolic acid 20-45%
- » Lactic acid 50%
- » Salicylic acid 20-30%
- » TCA <20%

Superficial ► Eliminates the stratum corneum (EC)

- » Glycolic acid 50-70%
- » TCA 20%

Medium (ADVANCED PEELS)

- » TCA 35-40%
- » TCA 35% Glycolic acid 70%

Deep (ADVANCED PEELS)

- » TCA > 40%
- » Phenol

FACTORS THAT INFLUENCE THE DEPTH OF A PEELING

- » Type of acid
- » Concentration
- » pH
- » Cosmetic texture and shape
- » Preparation of the skin (use of retinol or other acids)
- » Application time and number of layers
- » Application technique
- » Skin type (dry, oily, thin)

This variety of factors requires a diversity of products that allow the execution of **safe and effective treatments** for chemical exfoliation treatments.

To this end, in **Neftis Laboratorios** we have developed two main lines:

- » Monocomponents peels (with a single active)
- » Combined peels (with optimal mixtures of acids)

Both lines allow professionals and users the application of exfoliation treatments with **perfect results for each different skin**.

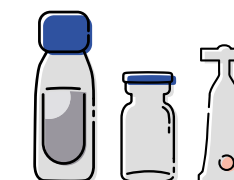
